
On June 21, 2019 at approximately 20:30 hrs the Federal B #3 had an increase in pressure (3200 psi). Suspect that pressure was a result of the hydraulic stimulation that was being performed on the North Alamito Unit #233H by DJR. Due to the proximity of the lateral and prior to DJR initiating their completion, measures were taken to ensure that any abnormal pressure would not affect the wellhead or related surface equipment. Currently, the well is flowing the contaminated gas to a flowback tank until the nitrogen levels are pipeline acceptable at which point the well will be returned to production.
