Based on well performance, suspect that there is a hole in the casing. Epic Energy, LLC, is proposing to set a retrievable bridge plug above the perforations and then isolate the hole(s) in the casing and design a cement squeeze based on those results. If the squeeze job is successful the BRP will be removed and the well will be returned to production.
