Plug #1: CICR at 3036' KB. Spot 35 sx (40.3 cf) of Class G in a balanced plug f 3036' - 2688' (confirm top w/ tbg). Run CBL f 2670' - surface.

Plug #2: Spot 15 sx (17.3 cf) of Class G in a balance plug f 1535' - 1350' (confirm top w/ tbg).

Perforate 3 holes at 150', establish circulation out BH valve. 71 sx (82.7 cf)

Plug #3: Pumped 71 sx (82.7 cf) of Class G for surface plug (150' - surface). Circulated good cement out BH valve.

Cut off wellhead below 7" casing collar. Top off 8-5/8" x 4-1/2" annulus. Install 6' P&A marker on 4-1/2" casing.

Plugging operation witnessed by Derrick McCuller w/ BLM - Farmington FO

Plan to start reclamation as per the approved plan with 90 days of this notice.
