

Final Reclamation Plan Revised 7-17-19

1. Pick up and remove all trash, metal, cable, and any foreign debris within 200' of location.
2. Harvest to look into removing pipe and installing water bar on road.
3. Cut off P&A marker, and replace with plate 18" deep.
4. Re-seed all disturbed areas. Drill where applicable at 12lbs an acre, and broadcast seed and harrow, at 24lbs an acre, all other disturbed areas. Broadcast seed a double the rate of seed. Wild life Mix seed mix will be used.
5. Submit FAN.



6. Dry hole marker will be below grade.
