1. Pick up and remove all trash, metal, cable, and any foreign debris within 200' of location.
2. Fix erosion in road. Add 2 water bars.
3. Spot seed road, and disk and re-seed location.
4. Re-seed all disturbed areas. Drill where applicable at 12lbs an acre, and broadcast seed and harrow, at 24lbs an acre, all other disturbed areas. Broadcast seed a double the rate of seed.  
Wildlife seed mix will be used.

5. *Dryhole marker will be below grade.*
