Hilcorp Energy Company requests permission to leave the isolation plug in the hole at 6260' and shut in the well. HEC obtained BLM/OCD approval in August 2019 for an extension of the PC only test for an additional 180 days. In June 2019 a CIBP was set @6260' to isolate the existing DK zone for the PC test after the Recomplete. Due to the current economic environment, HEC has submitted the well for ACOI shut in status with NMOCD.
