XTO Energy requests an exception to NMOC rule 303A to permit DHC of production from the Basin Dakota pool (71599) and the Otero Chacra pool (82329). XTO proposes to DHC the two pools upon completion of the well. Proposed allocations are based on a 9-section EUR & recommended allocations are:

Basin Dakota: Gas 87% Water 83% Oil 100%
Otero Chacra: Gas 13% Water 17% Oil 0%

Ownership in pools is diverse & notification was made to owners by certified mail, return receipt on 4/12/06. DHC will offer an economical method of production while protecting against reservoir damage, waste of reserves & violation of correlative rights. An application for DHC was submitted to BLM 5/3/06.
