05/05/06 Drilled 12/14" hole to 190', ran 9 5/8", 36# J-55 STC Casing, landed @ 180' KB (KB=13.0) Cemented with 114 sks, 15.2#, Type III Cement plus 3% CaCL, plus 0.25 lb/sk Celloflake, yield 1.28 145.92 cu. ft. We used 3 centralizers on the bottom 3 joints. Circulated 18 bbls cement to surface. Wait on cement +/- 12 hours.

Tested BOPs 250# low and 2000# high for 10 minutes each. Tested 9 5/8" casing to 600# for 30 minutes, held O.K..

05/06/05 Tagged cement @ 140' in 9 5/8" casing.
