Cement with 125 sks Class G, 2% CaCl₂, 1/4#/sk floccle (147.50 cu.ft.). Plug down @ 16:30 on 05/08/06. Circulate 10 bbls cement to surface. RD Halliburton. WOC. NU BOP. Test casing & BOP to 600 psi - ok.
