1/30/06 For the above referenced well we failed twice to set surface casing. On the initial attempt w/ MOTE #2; lost circulation while drilling @196' & experienced severe cave-ins that forced rig off location. Subsequently used earth moving equipment to excavate area of 60' x 20' x 10' around the stake, filled in & compacted the excavation w/road base material.

Attempted to drill surface hole with AWS #184 & again experienced severe washouts & cave-ins while drilling @ 90'. Before we moved the rig off location; pumped cmt into cavity until we observed returns at surface.

Since moving location does not appear feasible, on April 10, 2006 verbal approval was granted by Adrienne Brumley (BLM) for the following procedure:

Move in with MOTE #2 & drill 17.5" hole to 80' – 100'

RIH & cmt 13 3/8" 48# conductor pipe

Drill out 12 1/4" hole to 240'

RIH & cmt 9 5/8" 32.3# surface pipe.
