XTO Energy Inc. requests approval for an exception to NMOC Rule 303-C to permit DHC of production from the Basin Dakota & Otero Chacra in the Kutz Federal #10F. XTO Energy, Inc. proposes to downhole commingle these pools upon completion of this well.

Allocations are based upon a 9-section EUR and are calculated as follows:

Basin Dakota

Gas: 100% 83% Water: 83% 57% Oil: 57% 100%

Otero Chacra

Gas: 0% 12% Water: 12% 43% Oil: 43% 0%

Both pools are included in the New Mexico Oil Conservation Division pre-approved pool combination of downhole commingling in the San Juan Basin. Working Interest, net royalty interest & overriding royalty interest owners have been notified by certified, return receipt mail on 3/31/06. The NMOC has been notified of our intent by submission of a C-103. Downhole commingling will offer an economical method of production while protecting against reservoir damage, waste of reserves & violation of correlative rights.
