4/15/06 Drill 8-3/4" hole to 3770'. Land 7" 23# J-55 csg @ 3770'. Cmt w/410 sx (795 cf) 65/35 G/POZ w/6% gel, 1/4# flocele, 10# gilsonite, & 2% CaCl₂. Tail w/2% gel, 5# gilsonite, 1/4# flocele, 2% CaCl₂, & 0.4% Halad 9. Did not circ cmt. Pressure test csg, BOP's to 1000 psi for 15 min.


