Cement second stage with 560 sks 65/35 Class B poz, 6% gel, 5#/sk gilsonite, 1/4#/sk flocele, 2% CaCl2 tailed by 50 sks Class G, 5#/sk gilsonite, 1/4#/sk flocele (1170 cu.ft.). Plug down @ 8:30 am on 05/06/06. Circulate 105 bbls cement to surface. RD Halliburton. ND BOP. Release rig @ 6:00 am on 05/07/06.
