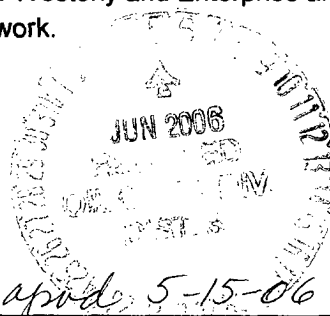

Westerly Explorlation has tested this well at 176 MCFD with a 93 psi FTP and a 239 psi FCP.

Westerly Exploration has signed a Gathering Agreement with Enterprise Field Service to connect this well to their system. Enterprise is currently acquiring the necessary rights-of-way. Westerly and Enterprise are diligently working on connecting this well and request a 180 day extension to complete their work.
