Yates Petroleum Corporation requests permission to make the following changes to the BOP system for this well:

Change BOP system from 2,000 psi, double ram preventer to a 1,000 psi annular preventer. The 1,000 psi annular preventer will be pressure tested with the rig pump. A schematic of the annular preventer and choke/kill lines is attached to this Sundry Notice. This change will allow the BOP system to fit under the floor of the rig that will be utilized, while still maintaining the ability to keep control of the well at all times.
