6) Plug #6: 27 sx Type III cmt (14.8 ppg, 1.32 cuft/sx). Ppd dwn tbg w/5.5 hbbs cmt. Cmt fr/985'-587'. Covered Kirtland, Ojo Almo).

7) Plug #7: 30 sx Type III cmt (14.8 ppg, 1.32 cuft/sx). Ppd dwn tbg w/6.0 hbbs cmt. Cmt fr/369'-surf. 8) Dug out WH. Cut off csg. Inst dry hole marker. Cleaned up location.
