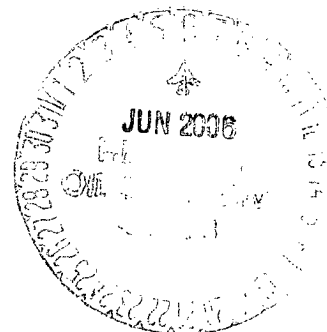

Cmt'd w/ 150 sx Class G cement w/ 3% CACL2 & 1/4# /sk Cellophane (175.5 cu ft.). Displaced w/14.8 bbl wtr. Circulated 15 bbl cement to surface. WOC. NU BOP. PT casing to 1000 psi for 30 minutes. Test ok. Drill ahead.
