Pumped preflush of 10bbls H2O, 10bbls mud, 10bbls H2O. Pumped 19sxs(57cu-10bbls)prem lite cmt w/3% CaCl2, .25pps Cell-o-Flake, 5pps LCM1, .4% FL52, .4% SMS. Cemented lead w/320sxs(682cu-122bbls)prem lite cmt w/3% CaCl2, .25pps Cell-o-Flake, 5pps LCM1, .4% FL52, .4% SMS. Tail in w/90sxs(124cu-22bbls)Type 3 cmt w/.25% Cell-o-Flake, 1% CaCl2, .2% FL525.
