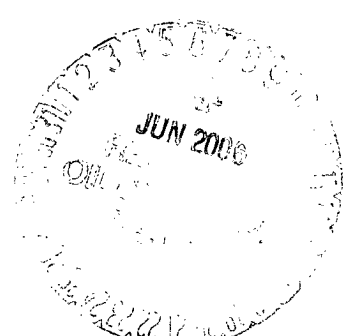

Cement with 500 sks 65/35 Class B poz, 6% gel, 10#/sk gilsonite, 1/2#/sk flocele, 2% CaCl2 tailed by 100 sks Class G, 5#/sk gilsonite, 1/4#/sk flocele (1104 cu.ft.). Plug down @ 11:15 am on 05/24/06. Circulate 30 bbls cement to surface. RD Halliburton. WOC. NU BOP. Test casing & BOP to 1200 psi - ok.
