Lance Oil & Gas Company, Inc plugged and abandoned the NW Cha Cha Unit #2 with operations commencing on May 12, 2006. Notified BLM and NMOCOD on 5/12/06 at 08:30 hrs. MI&RU A-Plus Well Service. TIH with 2 joints tubing and tag hard at 4,192' KB. Load hole with 5 bbls water and attempted to inject into perfs from 4,394' - 4,497' KB. Pressured up immediately to 600 psig and held solid. Called Wayne Townson with BLM and received verbal approval to set cement retainer at 4,180' KB. Tod Haanes with the BLM witnessed P&A.

Set cement retainer at 4,180' KB. Pressure test 4-1/2" casing to 1,000 psig for 15 minutes. Test - Good. TIH and land tubing at 4,180' KB. Set cement plug #1 with 13 sacks Type III cement from 4,040' - 4,180' KB to cover Gallup Formation top. TOO H and land tubing at 1,389' KB. Set cement plug #2 with 12 sacks Type III cement from 1,270' - 1,389' KB to cover Mesaverde top. TOO H and land tubing at 410' KB. Set cement plug #3 with 34 sacks Type III cement from surface to 410' KB. Circulate good cement to surface. TOO H with remainder of tubing. Shut-in well and WOC overnight for 15 hours.

ND BOP's and RD & MO rig. Cut-off wellhead, install P&A marker with cement, cut-off anchors and clean up location. Surface location will be reclaimed and seeded imminently.
