- 2) Set packer at  $\pm 2125'$  (end of 3 1/2" csg @ 2174', open hole completion 2174-2288').
- 3) Pressure test casing to at least 550# for thirty minutes.

Appropriate NMOCDD personnel will be notified at least twenty four hours prior to testing. Appropriate permission will be obtained prior to initiating the injection. AFMSS
