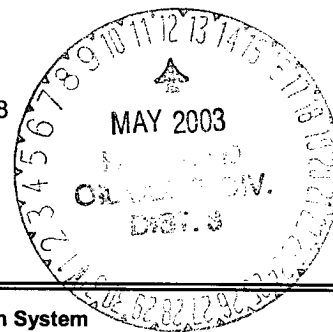

9 5/8" surface casing - cement with 32 sacks Class A, B Portland Type I, II cement (38 cu.ft. of slurry, bring cement to surface) or equivalent. Wait on cement for 24 hours for pre-set holes or 8 hours for conventionally set holes before pressure testing or drilling out from under surface casing.
