Set sq pkr @ 640'. Cem w/100 sx Cl 'B' + 2% CaCl. Sq over 60 min to 2000 psi w/800 psi on annulus. TOOH w/tbg & pkr, drill cem from 640'-750', good cem. Drill cem 750'-756'; circ hole clean to 800'. Press test csg - no test. Found csg leaks between 752'-817'. Set sq pkr @ 664'; sqz w/75 sx Cl 'B' + 2% CaCl to 2000 psi w/800 psi on annulus. TOOH w/tbg & pkr; drill cem from 664'-796'. Circ hole clean to 1000'. Press test csg - no test. Found csg leaks between 769'-796'. Rn CBL/CCL/GR from 817' to surface. Perf 703'-709' & 720'-726', 4 spf, 120 deg phase. Set CIBP @ 764'. TIH w/pkr; press test CIBP to 2000 psi, ok. Acidize perf w/600 gal 15% HCl/Fe acid. Frac w/307 BW & 15,360# sd. Avrg 15.1 BPM & 646 psi. Flow well, CO to 764'. TIH w/23 jts 2-7/8" tbg w/NC @ 734'; SN @ 703'. Ran 1-1/4" pump on 27 - 3/4" rods & one 4' - 3/4" pony rod & PR. RDMO 4/23/04.
