Black Hills Gas Resources drilled a 7-7/8" hole to 3810'. They ran 5-1/2" 15.5# J-55 production csg and set @ 3816' on 4/27/05. Cemented w/650 sacks cmt (1169 cf). Circulated 0 bbls cement to surface. They plan to pressure test and run CBL during completion operations.
