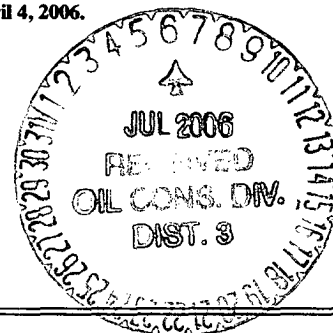

On May 17, 2006, Operator, Lance Oil & Gas Company, Inc., performed an acid job on the Salty Dog #6 SWD perforations of 6,775 - 6,880' KB with 4,900 gals of 15% HCL acid, 3,000 gals gelled 20% KCL water and 9,000 lbs rock salt with a maximum injection pressure of 2,210 psi and SD ISIP of 1610 psi.

Operator commenced injection under the originally approved Administrative Order SWD - 974 dated April 4, 2006.
