Drilled 12 1/4" hole to 300' on 5/17/06, set 9 jts of 9 5/8", H-40, ST&C, 32.3# casing at 293'. Cemented w/175 sx (37 bbls) "B" cement w/2% CaCl and 1/4# PSX Floceal. Circulated 15 bbls of cement to surface. Test casing to 1,500 psi.

Drilled 8 3/4" hole to 3,140' on 5/21/06, set 71 jts of 7", J-55 LT&C, 23# casing at 3,128'. Cemented lead w/550 sx (144 bbls) 50/50 POZ cement w/3% Gel, 5# Gilsonite, 1/4# Flocele, 0.1% CFR 3, 0.4% Halad 344 and tail w/75 sx (16 bbls) STD "B" cement w/0.4% Halad 344. Circulated 30 bbls of cement to surface. Tested casing to 1,500 psi.

Drilled 6 1/4" hole to 3,700' on 5/22/06, set 87 jts 4 1/2", J-55, LT&C, 11.6# casing at 3,690'. Cemented lead w/225 sx (58 bbls) 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL and tail w/75 sx (19 bbls) 50/50 POZ, 3% Gel, 1 4/105 Halad 9, 1/10% CFR3, 5# Gilsonite & 1/4# Flocele. No cement to surface, top of cement is at 300'. Landed 2 3/8" production tubing at 3,528'.
