Drilled 12 1/4" hole to 300' on 5/25/06, set 9 jts of 9 5/8", H-40, ST&C, 32.3# casing at 293'. Cemented w/175 sx (37 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 15 bbls of cement to surface. Test casing to 1,500 psi.

Drilled 6 1/4" hole to 4,084' on 6/4/06, set 96 jts 4 1/2", J-55, LT&C, 11.6# casing at 4,067'. Cemented lead w/400 sx (105 bbls) 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL and tail w/100 sx 50/50 POZ, 3% Gel, 1 4/105 Halad 9, 1/10% CFR3, 5# Gilsonite & 1/4# Flocele. No cement to surface, top of cement is at 500'. Landed 2 3/8" production tubing at 3,993'.
