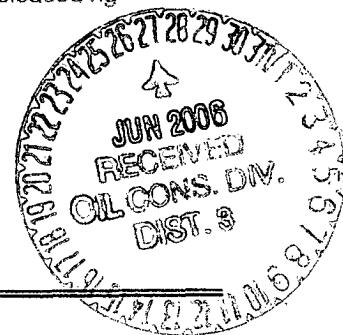

Tested well on 1/2" choke for 540 MCF/D. Landed 2-3/8" 4.7# J-55 tbg @ 3868'. Released rig 12/11/05.
