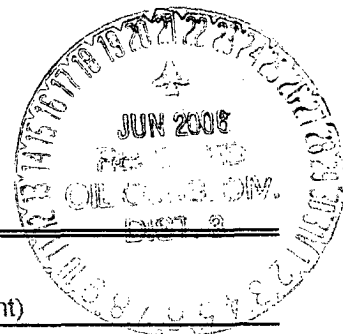

Tail w/150 sx (219 cf) 50/50 POZ cmt w/3% gel, 5.3# gilsonite, 0.2% CFR3, 1/4# flocele, & 0.2% supcbl. Circ 17 bbl cmt to surface. Plan to pressure test 5-1/2" csg during completion operations.
