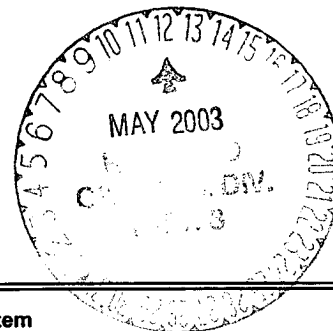

Cmt'd csg w/260 sx Type III cmt w/8% gel, 2% CaCl2 & 1/4#/sx celloflake (mixed @ 12.5 ppg, 2.24 cuft/sx followed by 100 sx Type III cmt w/2% CaCl2 & 1/4#/sx celloflake (mixed @ 14.5 ppg, 1.41 cuft/sx). Circ 51 bbls cmt to surf. PT BOP's & surf csg to 2,000 psig for 30 minutes. Held OK. Durango BLM official on location during BOP test.
