Cmt'd lead w/375 sx class G cement w/3% D-079, 2% D-046, .25#/sks D-029 (967.5 cu ft). Tail in w/100 sx 50/50 G-POZ, 2% D-20, .1% D-46, .5#/sks D-24, .15% D-65 (125 cu ft). Drop plug and displace w/114 bbl of FW. Bump plug to 1500 psi. Circulated 50 bbl of cement to surface. PT will be conducted by completion rig.
