Ran 5-1/2", 24#, J-55 casing to 6849' KB. Cmt'd 1st stage w/220 sx of Prem Lite cmt w/0.2% CD-32, 1/4 pps Celloflakes, 0.5% FL-52, 0.2% Phenoseal & 2% KCl (12.5 ppg & 2.01 cuft/sx) f/b 150 sx Type III cmt w/ 0.3% CD-32, 1/4 pps Celloflakes, 0.2% FL-52 & 0.2% Phenoseal (14.2 ppg & 1.48 cuft/sx). Cmt'd 2nd stage w/370 sx Type III cmt w/8% Bentonite & 1/4 pps Celloflakes (11.9 ppg & 2.6 cuft/sx) f/b 100 sx Type III neat cmt (14.2 ppg & 1.48 cuft/sx). Circ 20 bbls cmt to surf.
