Stage: 1, Lead, 100 sks G/TXI 25:75 Blend w/ .25#/sk D29, 3% D79, .2% D46, 5#/sk D24. Yield 2.11, density 11.7 #/gal WOC 4 hrs.
Stage: 1, Tail, 50 sks 50/50 G:Poz 2% Gel, .25#/sk D29, 5#/sk D24, 1% S-1, .15% D65. Yield 1.26, density 13.5 #/gal. 3 bbls. cement circulated to surface. Top of Cement @ 3040'

Stage: 2, Lead, 375 sks G/TXI 25:75 Blend w/ .25#/sk D29, 3% D79, .2% D46, 5#/sk D24. Yield 2.11, density 11.7 #/gal
Circulated 45 bbls cement to surface WOC 12 hrs.

6/8/06 - Pressure tested casing to 1000 psi for 30 mins. Test BOP to 1000 psi. Held OK.
