Pump preflush 4 bbls H2O, pumped 34sxs (.54cf - 9.6 bbl slurry). Type I-II Portland Cement w/20% Fly Ash. Dropped Plug & displaced with 4.2 BBL H2O. Circ. 3 bbls cement to surface. WOC, install wellhead, RDMO.
