WOC. Install WH, NU BOP. PT - OK. PT casing to 1000# - lost 105# in 30 min. BLM rep Cliff Olham gave approval to continue since cement to surface. Called Henry OCD and also received approval to continue with stipulation to try to get 7" casing cement to surface.
