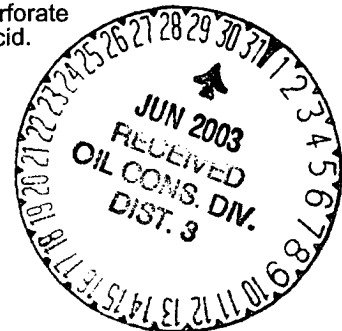

Pressure test casing to 3000 psi, held. Run GR-CCL-CNL from PBTD (1340') to surface. Perforate Fruitland Coal from 1234'-1250' w/4 spf (total 60 holes). Acidize w/250 gallons 10% formic acid. Frac w/8,500# 20/40 Brady sand (well screened out). Land 2-3/8" tubing @ 1291'.
