Cavitation operations for the subject well have been underway for 11 days. The well is not responding as planned. Devon Energy requests approval to deepen well from 3206' to 3256'. Run 5-1/2" casing from TD to surface. Cement (50/50 Poz) will be run through the openhole and tied into the 7" by 400' (est. 140 sx). We will then shoot ho throughout the coal interval and frac with sandwedge.

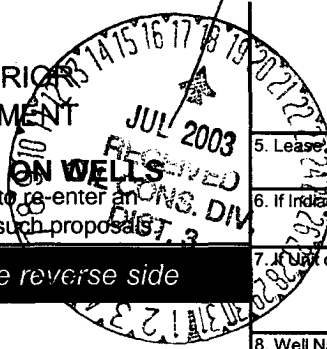
