As per verbal conversation between Brent Martin (XTO Drilling Mgr) and Adrienne Brumley (BLM rep) the following changes were discussed to change the intended completion effort from the originally proposed Blanco MV completion to a FC/PC test:

Current Wellbore Condition: 8-5/8" surf pipe set and cmtd from 379' back to surf. Original borehole drilled to 6452' MD before loss circ encountered. Stuck pipe during setting of cmt plug and back-off made @ 5892'. After fishing efforts failed, set a cement plug and sidetracked hole @ 5580' and drilled to 6586' MD fighting loss of circ. Set a cmt plug and sidetracked hole @ approx 5580' and drilled to 6586' MD (fighting loss of circ). Set a second cement plug and stuck DP again. Made back-off @ 6052' MD. Cliffhouse Sandstone estimated @ 5964' MD/5921' TVD.

Proposed Action to be Taken: Isolate the top part of the Cliffhouse SS with a min 100' length cmt plug with a min 200% open hole excess factor and top of plug a min of 50' above the Cliffhouse SS. Location of the plug is to be confirmed w/tag with the drillstring. 5-1/2" prod csg is to be run and cmtd after the cmt plug is placed and tg'd. Approval for completion attempts in the FC/PC is contingent on Dir Surveys submitted to show exact location of proposed zones and submittal of appropriate paperwork.
