This well is currently experiencing circulation problems in the coal. Current Intermediate TD is 3461'. If the circulation problem persists, ConocoPhillips plans to set sand plug to Fruitland Coal or deeper (across losses) and set 7" casing, cement to surface, and mist drill to TD. We plan to run 4 1/2" casing and cement as per original well plan. Verbal approval given by Steve Mason 7/21/06. Verbal approval given by Steve Hayden (OCD) 7/21/06.

Conocophillips requests approval for possible change of scope in cementing plan. This well is permitted for 1-stage cement job on 7" casing but we may decide to perform 2-stage procedure instead. We anticipate no change in cement volumes. DV tool will be set at approximately 3100' - 3200'. Verbal approval given by Steve Mason 7/21/06.
