Chevron Midcontinent, L.P. proposes to replace the outdated, damaged and less efficient plunger lift controller on this Rincon Unit well. This new modern controller will react to line pressures resulting in increased run times and uplift of production in this well. Remote electronic monitoring and trouble shooting along with development of historical plunger/production performance are other enhancements that will result from this plunger lift controller upgrade.
