Preflush w/20 bbls of FW and Gel ahead of Lead cement 440 sx (1157 cf - 204 bbls slurry) CEM-NET, G, 3% D-79, .2% D-46. Tail cement 100 sx (128 cf - 22 bbls slurry) CEM-NET, 50/50 G-POZ, 2% D-20, 5#/SX D-24, 2% S1, .1% D-46, .15% D-65. Dropped plug and displaced w/82 bbls of FW. Bump plug to 1600#. Circ. 75 bbls of good cement to surface. RD and release cement crew. ND BOPE, dropped and set slips and install trash cap. Release rig. 8/6/06
