1. MIRU. Kill well. ND wellhead. NU BOP.
2. Pull 2.3/8" tubing.
3. TIH with 4.75" bit on a 3.50" workstring. Drill out to 2117'. Condition hole to run casing. TOH.
4. Run 3.50" casing to TD. Cement and circulate back to surface. WOC.
5. Run cased hole log from TD to 1600'. Selectively perforate the Pictured Cliffs formation.
6. Fracture treat the PC.
7. Clean out to PBTD. Run 2-1/16" tubing to bottom perf.
8. Turn back on to production.
