08/08/06 spud 8-3/4" surface hole. Drilled to 128'KB. Ran 3 jts (118.27') of 7", 20#, J-55, ST&C new LS casing and set casing at 124'KB. Cemented with 55sx (65 cu. ft.) of Type 5 with 3% CaCl<sub>2</sub>. Circulated 5.0 bbls of good cement to surface.

08/09/06 Nipped up the BOP and pressure tested the casing and BOP to 1000 psi.

08/10/06 TD 6-1/4" hole at 1900' KB. Ran 49 jts (1874.82') of 4-1/2", 10.5#, J-55, ST&C production casing and landed at 1880.40' KB. Insert float is at 1858'KB. Cemented with 150 sx (309cu.ft.) of Type 5, 2% sodium metasilicate, 1/4#/sk celloflake, followed by 75 sx (89 cu. ft.) of Type 5, with 1/4# celloflake. Bumped plug to 1500 psi. Circulated 12bbls of cement to the surface.
