Cement with 500 sks 65/35 Class G poz, 6% gel, 10#/sk gilsonite, 1/2#/sk floccle, 2% CaCl2 tailed by 100 sks Class G, 5#/sk gilsonite, 1/4#/sk floccle (1104 cu.ft.). Plug down @ 11:30 am on 06/19/06. Circulate 20 bbls cement to surface. RD Halliburton. WOC. NU BOP. Test casing & BOP to 1200 psi - ok. Released rig on 06/20/06.
