RIH (7-7/8") w/5-1/2", 15.5#, J-55 csg to 6824' KB. Cmt'd 1st stage w/336 sx Prem Lite cmt w/1/2 pps celloflake, 0.5% FL-52 & 2% KCl (12.5 ppg & 2.01 cuft/sx) f/b 200 sx Type III cmt w/0.3% CD-32, 1/4 pps celloflake & 0.2% FL-52 (14.2 ppg & 1.52 cuft/sx). Circ 30 bbls cmt to surf. Cmt'd 2nd stage w/425 sx Type III cmt w/8% Bentonite & 1/4 pps celloflake (11.9 ppg & 2.6 cuft/sx) f/b 100 sx Type III neat cmt (14.5 ppg & 1.39 cuft/sx). Circ 60 bbls cmt to surf.

Production casing will be tested upon completion.
