Tail with 100 sx (133 cf) 50/50 POZ, 2% gel, 2% CaCl<sub>2</sub>, 0.3 Halad 344, 5# gilsonite, 1/4# flocele, (yield 1.33). Circulate 42 bbls cement to surface.
