Perfed PC @ 3646'-50', 3655'-57', 3660'-62', 3665'-68', 3672'-74', 3676'-77', 3691'-93', 3700'-03' w/4-0.41" SPF. Total 76 holes. Broke down perfs w/1400 gallons acid. Fraced PC w/88,695# sand in 75Q foam. Clean out after frac & tested PC on 1/10/06 for 0 MCF/D (wet). Set CIBP @ 3402'.

Spot 250 gallons 7-1/2% HCL acid across proposed Tertiary perfs. Perf Tertiary (Ojo Alamo) @ 3232'-52', w/2-0.42" SPF. Total 84 holes. Fraced Tertiary w/130,000# sand in 70Q foam. Clean out after frac & tested 0 MCF/D on 1/17/06. Landed 2-7/8" 6.5# J-55 tubing @ 3350'. Ran pump & rods. Completed as a single pumping Tertiary gas well w/PC open below a CIBP @ 3402'. Released rig 1/20/06.
