2/4/06: Spud well. Drill 12-1/4" hole to 283'. Run 8-5/8" 24# J-55 casing & set at 283'. Cement with 200 sx (236 cf) regular cement with 2% CaCl2 and 1/4# flocele. Circulate 20 bbls cement to surface. Pressure test casing to 600 psi - OK.

Drill 7-7/8" hole to 3743'. 2/9/06. Ran 5-1/2" 15.5# & 17# J-55 casing and landed @ 3743'. Cemented with 500 sx (980 cf) 65/35 POZ with 10# gilsonite and 1/4# flocele. Tail with 150 sx (219 cf) 50/50 POZ with 3% gel, 0.5% Halad 9, 5# gilsonite, 1/4# flocele, 0.2% CFR3, 0.1% CBL. Circulate 30 bbls cement to surface. Plan to run CBL & pressure test during completion operations.
