Pumped preflush of 20 bbls FW & Gel Ahead, last 10 bbls w/GD. **Lead-** pumped 445 sx(1148cf - 205 bbls) Type G cement w/3% D-079, .2% D-046, & .25 #/sx D-029. **Tailed** w/100 sx(125cf- 23 bbls) 50/50 G-POZ cement, w/2% D-20, .1% D-46, 1% S-001, .5 #/sx D-24, & .15% D-65. Dropped plug, bumped plug w/132 bbls FW. Plug down & holding @ 3:30 pm on 8/10/06. Circ 130 bbls cement to surface. RD & release cement crew. ND, BOPE. RR @ 12 AM 8/11/06.
