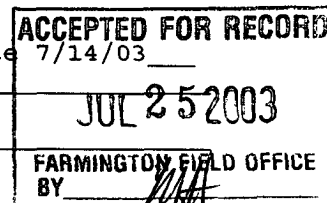

7-8-03 TIH w/pkr, set @ 5510'. Load hole w/wtr. PT CIBP @ 5530' to 3000 psi/15 min, OK. Reset pkr @ 5050'. Load annulus w/wtr. PT annulus to 3000 psi/15 min, OK. Have csg leak within Lewis perforation interval. Release pkr, TOOH. SDON.
